You are entitled to a 50% reduction in your water and/or sewer bi-monthly base rate on your billing cycle. For example, the reduction for District customer with a <sup>3</sup>/<sub>4</sub>" water meter would be as follows:

Water Base Fee <sup>3</sup>/<sub>4</sub>" meter - \$43.91 ..... Discount: \$21.96 Water Base Fee 1" meter - \$74.96..... Discount: \$37.48

Sewer Base Fee - \$44.48 ..... Discount: \$22.24

**PROOF OF INCOME** – (All that apply) Income Tax, 1040, EZ, and/or Supplemental Security Income statement (SSI), Social Security Disability Income statement (SSDI), etc.

**PROOF OF AGE** – (For Senior Citizens only) – one of the following will work: Driver's License, Social Security statement, Birth Certificate, or Passport.

**PROOF OF DISABILITY** – (For Disabled only) – current copies of SSI, SSDI, or payments from another program for persons with disabilities. Access and accommodations provided to persons with disabilities.
